I-140 Petition Review Service

Petition review service is offered to buyers who prepare their petition based on DIY packets purchased from GreencardforPhD.com. Currently, cost of first review service is \$180 and every additional review is \$80.

Review service includes (subject to terms and conditions in this document):

One set of thorough review of (send all documents at once. Follow instructions below)

- a) One I-140 petition
- b) Reference letters
- c) CV
- d) List of exhibits (only the list not all exhibits)
- e) Filled forms, if you feel necessary.

Every additional round of review costs \$80 and will only look at changes after the first review.

Instructions:

1. Please follow the suggestions in our DIY-packet and prepare your petition using the instructions. You need not have to rigidly adhere to the words in the petition. Please prepare what you think would result in the best outcome.
2. Since the service is offered at a low fixed price, please follow the below instructions carefully in order to receive maximum benefit from the review. Please avoid incomplete documents. *Incomplete set of documents may result in partial or delayed review and we may be have to do a second review at an additional cost.*

3. Send us a copy of **nearly complete** petition preferably in the Microsoft word format. Other accepted formats include pdf. If you send us a pdf, comments will be marked inline and you would need an appropriate reader (free acrobat reader or free pdfxchange) to read the comments. You can include some documents as word (ex. petition) and others as pdfs (ex. Recommendation letters) if you wish.
4. The documents you send us should include a) **complete** petition letter b) **all** recommendation letters c) list of exhibits (we only need the list, actual exhibits are not necessary. If you wish to include you can) and d) a copy of your CV. Send the documents in one email. Zip the documents if necessary.
5. If you think you need help with your filled forms, please include them as well.

Terms and Conditions

1. Our review service is not intended to be a through support for preparing the entire petition. It is the buyers responsibility to prepare a good petition following the instructions of your DIY packet.
2. Our review service is a thorough assessment, to the best of our knowledge, of your petition to see if you satisfy the requirements of USCIS. This is based on our knowledge gained from looking at several petitions in the past.
3. A good review is not a guarantee that your petition will be approved. Please note that there is an element of subjectivity in the assessment, which may differ from what a USCIS officer thinks. In the past our reviews have had very positive outcomes.
4. Allow 7 to 10 working days for each review.
